PRIVACY POLICY ("Privacy Policy")

Woman's Walk Adventures, LLC ("we," "us," "our") operates the website womanswalk.net and organizes in-person and online events. We respect your privacy and are committed to protecting it. This page informs you of our policies regarding the collection, use, and disclosure of personal data collected when you visit our website or register for one of our events or other services. This Privacy Policy also applies to information collected through our social media accounts.

"Personal Information" refers to any identifying or descriptive information that is capable of being associated with, or could reasonably be linked to a specific customer or individual. Publicly available information, such as information available from government records, is not considered personal information.

INFORMATION COLLECTION

We collect several different types of information from various sources and for various purposes, to provide and improve our customer service.

1. Information You Directly Provide Us

<u>Use of Our Website:</u> Womanswalk.net offers certain features that may ask you to provide Personal Information including but not limited to your name, email address, and phone number. For example, if you sign up for our email list, send us an email, use our contact form, or register for an event, you will be asked to provide, at a minimum, your name, email address, and phone number. If you comment on a blogpost, your name may also display with the comment.

<u>Newsletters, Events, Guides, and Resources:</u> If you choose to provide us with your email address or join our mailing list, we may send you periodic emails to share updates about our events, resources, and other information that relates to Woman's Walk Adventures and its mission. You can opt out of receiving emails from us by following the instructions outlined below.

<u>Social Media:</u> You may provide Personal Information to us through use of our social media platforms (e.g., Facebook, Instagram, YouTube, Pinterest). Please remember that any information you post, including comments and photos, will become publicly available.

Registration for Events and Services: Our Website offers certain features, such as registering and submitting payment for events and services and completing liability waivers for said events and services. These activities may require you to share Personal Information, including but not limited to your name, email address, physical address, phone number, emergency contact, and credit card information. We may use third-party service providers to offer these services to you. Each third-party service provider's use of your Personal Information is dictated by its respective privacy policy. We encourage you to review those privacy policies. For more information about our third-party service providers, please see the below section "Third-Party Use of Personal Information."

2. Automatically Collected Information (Information You Do Not Directly Provide Us)

We may also collect information on how our website and services are accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address ("IP address"), browser type and version, the pages of our site that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data. We collect this information in order to improve our Website and your user experience while on our Website. Several methods may be used to college Usage Data, as discussed below in "Cookies and Related Technologies."

We may track visits to the pages, links on our websites, and create and use other forms of anonymous information (aggregate or deidentified information that does not identify you as an individual). This type of anonymous data may be provided to other parties for marketing, advertising, or other uses. Examples of this anonymous data may include analytics or information collected from cookies.

In addition to the purposes described above, we may use the information we collect to comply with laws and for our legitimate business interests, including;

- To create a user account for you;
- For business functions and communications such as to respond to your comments or inquiries, process your transactions for events and services, and manage records;
- For marketing purposes;
- To provide website support to users and customers;;
- To comply with legal, ethical, or regulatory obligations or requirements, including disclosures designed to eliminate potential risks to you or others;
- To detect, prevent, investigate, or provide notice of fraud, unlawful or criminal activity, or respond to law enforcement requests; and
- To enforce our Terms of Use and other agreements.

DISCLOSURE OF YOUR INFORMATION TO THIRD PARTIES

We do not sell your Personal Information and do not share your Personal Information with third parties, except for as otherwise provided in this section. We share Personal Information with the following categories of recipients.

<u>Third-Party Service Providers</u>: The Website may share your Personal Information with third-party service providers to service various aspects of the Website and provide us with services such as website hosting, information technology services, and related infrastructure, e-mail delivery, auditing and similar services. These service providers may have access to your Personal Information to perform their functions but are prohibited from using Personal Information for any purpose other than providing services to us.

<u>To Perform Services for You:</u> We may disclose your Personal Information to third-party service providers who provide services to you. In the event that you choose to use a service offered by our Website that allows or requires you to interact with such a third-party service provider, that provider's separate terms of use and privacy policy may govern the collection and use of your Personal Information.

<u>Marketing:</u> We may use third parties for our marketing purposes, as described further below in "Advertising and Third Party Data Collection."

Other Legal Reasons: We may share your Personal Information with third parties if we conclude that we are required by law or have a good faith belief that access, preservation, or disclosure of such information is reasonably necessary to protect the rights, property, or safety of our Company, its customers, or the public. Additionally, we may disclose your Personal Information to third parties in connection to legal proceedings brought by or against us.

COOKIES AND RELATED TECHNOLOGIES

We may use cookies and related technologies to collect the information described above. Cookies are small data files stored by your browser on your computer's hard drive. Cookies help us provide customized features or services based on your past preferences. We may use both session cookies, which expire when you close your browser, and persistent cookies, which stay on your browser until deleted, to provide you with a more personalized experience on the Website.

You may prevent the Website from using cookies at any time by adjusting your browser options settings. Already set cookies may be deleted at any time via your internet browser. While you generally can use our Website without cookies, please note that it you deactivate cookies in your Internet browser, you may not be able to use certain features of our Website.

Cookies may also be used by third-party web analytics services, such as Google Analytics. We use Google Analytics to collect and analyze Website usage information. Google Analytics may capture your IP address, but no other personal information is captured by Google Analytics. To prevent Google Analytics from using your information for analytics, you may install the Google Analytics Opt-out Browser Add-on by clicking here.

Our advertising and marketing partners may also use cookies, as described further in "Third Party Service Providers" above.

Retargeting Ads

From time to time, the Website may engage in remarketing efforts with third- party companies, such as Google, Facebook, Instagram, MeetUp, or Eventbrite in order to market the Website. These companies use cookies to serve ads based on someone's past visits to the Website.

Affiliate Program Participation

The Website may engage in affiliate marketing, which is done by embedding tracking links into the Website. If you click on a link for an affiliate partnership, a cookie will be placed on your browser to track any sales for purposes of commissions.
